There were no other instances requiring to obtain any approval by the company from the Central Government, Regional Director, or such other authorities as may be prescribed under the various provisions of the Act during the said financial year.

14. The Company being a Core Investment Company (CIC) during financial year under review, has not accepted public deposits;
